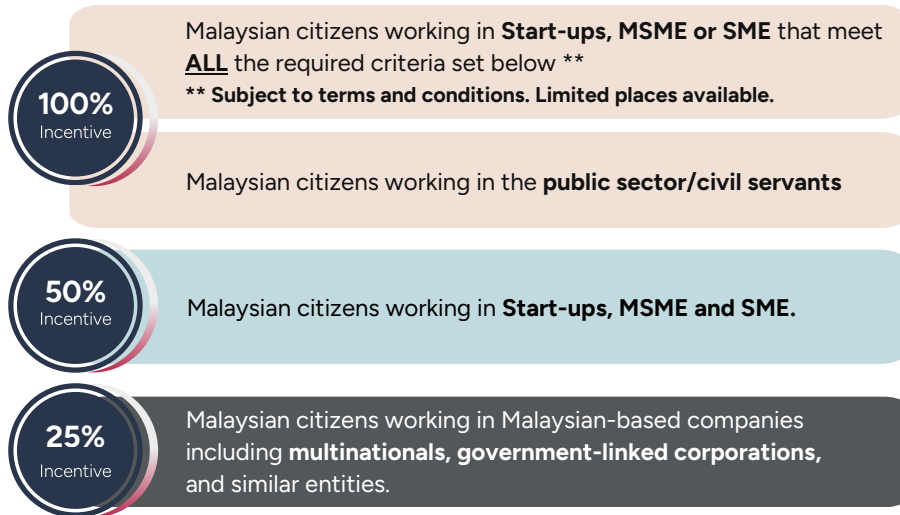


Malaysian citizens and locally incorporated companies are encouraged to register for the Executive Digital Leadership Programme (EDLP) which offers various incentive schemes curated by MyDIGITAL Corporation as depicted below.



ARE YOU ELIGIBLE FOR FUNDING? **

A locally incorporated company may qualify for the incentive scheme if it meets **at least one** of the criteria listed in **Diagram 1**.

SMES ***

Start-ups, SMEs, and MSMEs are eligible to apply if they meet at least one of the criteria in Diagram 1, along with the additional criteria set out below.

	Annual \$\$ Sales Turnover	Total of Full-Time Employees
Manufacturing	From RM300,000 to less than RM 3 million	100 or less
Services & Other Sectors	From RM300,000 to less than RM 3 million	50 or less

*** SMEs operating in **digital sectors or related fields that do not fulfil the above criteria** may still submit their applications. Such applications will be subject to **case-by-case evaluation by MyDIGITAL Corporation**.

DOCUMENTS REQUIRED DURING REGISTRATION

To be eligible for the incentives, these documents are **required to be uploaded during registration.**

Eligibility: Open to **Malaysian start-ups, MSMEs, and SMEs** that meet **ALL** the required criteria.

- ✓ **MSME Status Declaration Certificate** from SME Corporation Malaysia (SME Corp)

- ✓ Latest **EPF** and **SOCISO** contribution statements
- ✓ **LHDN Form C** (tax submission form)
- ✓ Latest **audited financial report** (year-end)
- ✓ Latest **three (3) months' bank statements**

Eligibility: SMEs that do not meet the above criteria are encouraged to apply under the 50% Incentive Scheme.

MSME STATUS DECLARATION CERTIFICATE

The MSME Registration Status System is a new initiative developed by SME Corporation Malaysia to certify that a company/business is a Micro, Small or Medium Enterprise (MSME).

Registration can be done via SME Corp - [MyBPI SME Corp](#). Applicants may share a screenshot of the registration/application while awaiting the official certificate (processing time is typically 1-2 weeks).

DOCUMENTS REQUIRED TO BE UPLOADED

Requirements vary slightly for Sdn. Bhd. companies and enterprise businesses:

- ✓ Latest **SSM registration documents**
- ✓ **Financial statements** – audited report (for Sdn. Bhd.) or profit & loss/management accounts and latest tax submission (for Enterprise)
- ✓ Latest **EPF** and **SOCISO** contribution statements
- ✓ Latest Annual Return (AR1) to verify company ownership (for Sdn. Bhd.)
